I/we grant permission to the Meet Directors or their designee or the assigned Chaperones of any USA Track & Field Junior Olympics Championship, competition or program to act as guardian/spokesman with full authorization and power to authorize emergency medical treatment, including hospitalization and anesthesia, if medically necessary, for my/our son or daughter while in route to/from or at the site of the USA Track & Field Junior Olympics Championship, competition or program.
