YOUTH NATIONAL INDOOR: MEET INFORMATION

SANCTION The YOUTH NATIONAL INVITATIONAL is sanctioned by the Illinois Association of USA Track & Field, the National Governing Body for track & field, race walking, road running and cross country, and the official representative of the United States in all international and Olympic Games competition.

ELIGIBILITY All athletes who meet the required age standards are eligible to compete: **Sub-Bantam/Peewee** (birthdate 1993-later), **Bantam** (1991-92), **Midget** (1989-90), **Youth** (1987-88), **Intermediate** (1985-1986), **Young Men/Women** (*1983-84). * Athletes born in 1982, who are still in high school, are also eligible to compete in this division. All athletes must compete in their true age divisions in <u>all</u> events <u>including relays</u>.

EVENT LIMITS <u>Peewee</u>, <u>Bantam</u>, <u>Midget</u> = 4 event limit (3 running events). <u>Youth</u>, <u>Intermediate</u>, <u>Young Men/Women</u> = 5 event limit (4 running events). <u>Limits include Relay-Team participation</u>.

MOVING UP All athletes must compete in their true age divisions — NO "MOVING UP"!

ENTRY QUALIFICATION There are no qualifying meets for the YOUTH NATIONAL INVITATIONAL; and there are no required qualifying marks to enter.

USATF MEMBERSHIP 2001 USATF Memberships are **REQUIRED**. Athletes who do not list a 2001 USATF number on their entry forms must submit a separate check for \$15.00, payable to "USATF Illinois". USATF memberships listed as "PENDING" or "APPLIED FOR" will not be accepted! \$20 if *received* after Feb. 2.

Note: Athletes who submit Entry Forms without USATF numbers or the extra check for \$15.00, will be charged the late Entry Fee due on the day the USATF number is supplied or the \$15.00 fee is paid. USATF memberships are \$20.00 if RECEIVED after Friday, Feb. 2, 2001. See USATF Membership form, on the next page.

USATF CLUB MEMBERSHIP Required for <u>Relay Teams</u>, only. NOT required for athletes competing in individual events. Clubs that enter Relay Teams must submit proof of 2001 USATF Club membership (approved copy of Club membership application or other direct verification from the Association).

Note: A separate personal or club check for \$50.00 will be accepted in lieu of proof of 2001 Organization/Club membership (checks will not be cashed until February 12!)

CLUB/TEAM ENTRIES CLUBS with Relay-Team entries are *required* to complete all their entries using <u>only</u> the "Club/Team Entry Form". Other Clubs/Groups may use either (not both) the Club Team or the "Entry Data Form".

PROOF OF AGE All competitors must be able to produce valid proof of age **On Site!** Athletes who are challenged and are not able to produce valid proof-of-age documents are subject to disqualification, and will not be listed in the results, and may not claim awards. <u>Illinois</u> athletes who were not USATF members in 2000 must <u>enclose</u> a birth certificate copy when applying for a USATF membership for 2001.

ENTRY FEES/DEADLINES \$7.00 per event if **RECEIVED** by Friday, Feb. 2. Entries **RECEIVED** prior to Feb. 2: Deduct \$2.00 per event. Athletes who submit incomplete entries(e.g. no USATF # or \$15.00, or no entry fees) will be charged the fee due on the day that they meet ALL entry requirements.

LATE FEES \$10 per event for all entries *RECEIVED* after Friday, Feb. 2. Except, entries *RECEIVED* after Tue., Feb. 6 will be accepted only if there are open heats or sections. ALL ENTRIES POSTED ON OR AFTER FRIDAY, 2/2 MUST BE SENT VIA OVERNIGHT MAIL OR ONE-DAY EXPRESS. Phone / FAX entries will not be accepted!

DROP-DEAD DEADLINE FOR ENTRIES Must be **RECEIVED** by Thursday, Feb. 8 at 5:00pm. NO NEW ENTRIES WILL BE ACCEPTED ON EITHER FEB. 10 OR FEB. 11.

REFUNDS Entry-fee refunds will be approved for requests *received* on or before Friday, Feb. 2. No refunds for USATF club or individual membership fees.

CLUB ENTRY CHANGES Event changes for those athletes listed on the "Club/Team Entry Form" may be made for no additional fee on or before Friday, Feb. 2. After Feb. 2., Club/Roster changes (if accepted!) will be charged \$3.00 extra. Listed late fees (\$10 each) will be charged for all NEW athlete entries. **NO substitutions allowed!**

ENTRY CONFIRMATION If your complete entries are RECEIVED by Friday, Feb. 2, and if you have enclosed a self addressed stamped envelope, we will mail you a confirmation. We will not confirm receipt of your entries by phone / FAX. Note: If you need to know that your entries have been received on time by USATF Illinois, send by registered mail and/or by one-day guaranteed delivery.

ENTRY FEE PAYMENT All entries and memberships must be paid by bank or postal checks. <u>Clubs and other groups of five or more athletes</u>: please submit separate payments for entry fees and USATF membership fees.

CHECK IN ONLY ON SITE at the TRACK, on Saturday, Feb 10 (after 6:30am), or Sunday, Feb 11 (after 7:00am).

AWARDS National Invitational Medals to the top SIX (6) Individuals and top THREE (3) Relay Teams.

USATF PRODUCTS and APPAREL USA Track & Field PRODUCTS and APPAREL (t-shirts, shorts, sweat shirts, pins, bags, etc.) will be sold on site. For a price list of same, request our "Apparel and Product Order Form"

FACILITIES Parking in south lot of Proviso West High School, adjacent to Field House/Track. Restrooms. No dressing rooms or showers. Concessions on site.

ADMISSIONS \$3.00 per day for adults, \$5.00 for both days. \$1.00 for students. Pre-school admitted free. **FREE** to any who show a 2001 USATF Membership Card.

TRACK SITE Hillside is located a few minutes west of downtown Chicago. Proviso West is just east of I-294/the Tri-State at the southeast intersection of Wolf Road and Harrison Street. Harrison Street is the first street south of I-290/the Eisenhower Expressway. From the Eisenhower, exit south on Mannheim (Hwy. 12 and 45) to Harrison, then west to Proviso West. From the North on the Tri-State, exit east on Cermak/22nd Street; From the South on the Tri-State exit east on Roosevelt Road. From Cermak or Roosevelt, continue east to Wolf Road; then north to Proviso West.

TRACK FACILITY Proviso West High School has an outstanding indoor track facility: Mondo Super X surface; inside rail on curves; six 42" lanes; two nine-lane 55 meter straightaways; double long jump/triple jump runways; two high jump pits; separate shot area. Seating capacity up to 2000 in balcony. Spikes: 1/8" or 1/4" allowed.


